# State of North Island Constitution

## **Article I - Consuls**

#### 1.1. Consuls

There is a set of 2 consuls.

A consuls responsibility includes the organization of Infrastructure projects, drafting laws, and granting citizenship.

#### 1.2. Election

Elections are organized by the President in accordance with Bloom's constitution.

Elections for Consuls happen every 2 months, voting lasts for 48 hours, Consuls are democratically elected by the citizens of North Island using the STV voting system via the website https://paul-lockett.co.uk/stv.html. To vote, a citizen must rank the available choices with 1 being their first choice, 2 being their second choice, 3 being their third choice and so on. If someone cannot vote in the discord, an alternative may be provided. The Bloom Parliament may schedule early elections for North Island's Consuls with a <sup>2</sup>/<sub>3</sub> majority.

#### 1.3. Dismissal

Consuls can be taken out of office with a  $\frac{2}{3}$  (two-thirds) majority vote by the Citizens.

Consuls may resign from office voluntarily.

If there is a vacancy then a by-election will be organised within 2 weeks to elect a new consul.

## 1.4. Constitutional Amendments

North Island's constitution may be amended by a  $\frac{2}{3}$  (two-thirds) majority vote from its citizens and it must then have the approval of the Bloom Parliament with a  $\frac{2}{3}$  majority.

# Article II - Citizenship

#### 2.1. Acquiring Citizenship

Consuls Grant citizenship if Both agree to give it

A citizen is defined as someone who has been granted land and citizenship by the Consuls.

Citizens must also already be citizens of Bloom.

Citizenship is only valid once the consuls approve it.

#### 2.2. Revoking Citizenship

Citizenship can be taken away if by a majority vote among citizens and 1 of 2 consuls agree.

#### 2.3. Legislation

All votes within North Island are done by a direct vote to the citizens of North Island lasting 24 hours

Citizens may draft laws and put them to a vote if they have two other citizens willing to support the law. Alternatively a consul may simply agree to put the law to a vote.

### 2.4. Voter Eligibility

Everyone is permanently registered to vote in local elections, as long as they have citizen status in both Bloom and North Island.

#### 2.5. Secession

North Island may secede if there is a  $\frac{3}{4}$  majority support for secession in a vote and the Bloom Parliament has then granted approval with a  $\frac{2}{3}$  (two-thirds) majority.

#### 2.6. Land Ownership

Land no matter how badly wanted, cannot be taken away from Citizens. All land is assumed owned by state until sold to its citizens at a consuls discretion.

### 2.7. Legislative Supremacy

Bloom law is assumed unless stated otherwise in laws or this constitution.
